## ADDENDUM INVITATION TO BID PARK STREET PARK IMPROVEMENTS BID #1021

The Lee County Board of Commissioners is accepting sealed written bids from qualified vendors for improvements to the Park Street Park, including the covering of four (4) 40 x 80 batting cages with an open air metal structure with metal roof complete with four (4) power outlets (one in each cage) and LED lighting. The Park Street Park is located at 166 Park Street, Leesburg, GA 31763.

A **pre-bid meeting was held Thursday, October 8, 2020 at 2:00pm** at the Parks and Recreation Office, located at 141 Park Street, Leesburg, GA 31763. Design plans and further details of the project will be made available at the pre-bid meeting. **You must have attended the pre-bid meeting in order to submit a bid.** If you choose to submit a written bid on this project, your **sealed bid must be marked "Park Street Park Renovations" and delivered to the County Clerk's Office of the T. Page Tharp Governmental Building located at 102 Starksville Avenue North, Leesburg, GA 31763, no later than 2:00pm on October 21, 2020.** All bids will be opened during a public bid opening at 2:05pm in the Opal Cannon Auditorium of the T. Page Tharp Governmental Building.

### ADDENDUM

- **Eave height of the building is to be set at 14'**
- **Each covered building will have a total of (4) 8' LED lights**
  - This will be 8 total 8' LED lights for project.
- **The recessed power outlet will be placed 15' from the pitching end of the cage and the power supply is to exit 5' to the side of the cage.**
  - This will be (1) outlet per cage.
  - This will be (4) total outlets for the project.
- **Turf Specifications**
  - 24 oz 11/32 pile height with 5mm foam backing
- **Netting Specifications**
  - 70' netting tunnel
  - 2.0 mm twisted knot polyethylene
  - 185 lb breaking strength
  - UV Treated/100% waterproof
  - 2mm size 1 3/4 square
