The Lee County Board of Commissioners met in a work session on Tuesday, April 8, 2025. The meeting was held in the Opal Cannon Auditorium of the Lee County T. Page Tharp Governmental Building in Leesburg, Georgia. Those present were Chairman Luke Singletary, Commissioner Dennis Roland, and Commissioner George Walls. Staff in attendance were County Manager Christi Dockery, County Clerk Kaitlyn Good, and County Attorney Jimmy Skipper. Vice-Chairman Chris Guarnieri and Commissioner Billy Mathis were absent. The meeting was also streamed on Facebook Live. Chairman Singletary called the meeting to order at 6:00 PM.

Commissioner Roland made the **MOTION** to approve the minutes from the March 25, 2025 Board of Commissioners meeting. Commissioner Walls seconded the **MOTION**. The **MOTION** was unanimous with Chairman Singletary voting yea.

Chairman Singletary and the Board recognized Lt. Grady Barfield with Lee County Fire and EMS for the completion of his Fire Chief Officer Certification at the Georgia Fire Chiefs Conference. Chairman Singletary thanked him for his dedication and hard work.

10. **COUNTY MANAGER'S MATTERS**

A) Updates on County projects.

County Manager Christi Dockery provided updates to the following County projects: (1) Great American Cleanup/ Amnesty Day had a great volunteer turnout this past weekend; and (2) the 2025 LRA (supplemental LMIG funding) application has been submitted and subsequently approved by GDOT for Ledo Road resurfacing.

B) Consideration to authorize staff to put out a bid for a video surveillance system for County buildings.

County Manager Christi Dockery summarized the need for an updated camera system as well as the desired locations. Funding for this project could come from either ARPA funds, Facilities, or SPLOST. The bid, when published, would list the buildings separately should one need to be pulled.

Commissioner Roland made the **MOTION** to authorize staff to put out a bid for a video surveillance system for County Buildings. Commissioner Walls seconded the **MOTION**. The **MOTION** was unanimous with Chairman Singletary voting yea.

C) Discussion of a speed hump policy.

Public Works Director Mike Sistrunk summarized the proposed policy and procedure for speed humps, stating once a request is received, he would like to place a speed trailer (the County owns two) at the location for a set period of time to gauge need and then a petition containing signatures from the majority of property owners (60%) would be collected. This process would be much more organized and streamlined than it stands currently. Data from the speed trailers would include traffic counts as well as vehicle speed and times. The Sheriff's Office could also benefit from this data as they can use it to know when extra patrol may be beneficial in an area.

Mr. Sistrunk stating that there were currently 46 speed humps out around the County, valued at approximately \$2,500.00 per set. Commissioner Roland asked about permanent speed bumps, to which Mr. Sistrunk stated a bid was put out for them several years ago, with pricing being obtained for both asphalt and concrete options. They are very expensive and much more difficult to install and remove.

Commissioner Roland suggested that every district be allotted a certain number of speed humps, with the commissioner getting to decide where they go. This item will be brought back to the Board at the next meeting, when all commissioners have time to review.

Tax Code.

An updated agreement and additional handout were provided to the Board. County Attorney Jimmy Skipper summarized the agreement, stating that per the current statute, hotel/motel funds must be spent on tourism and currently, the County's only real option is Chehaw Park. In the future, the legislation could be rewritten to involve the recreation projects on the 100 acre property. The presented agreement would be until June 30 (end of fiscal year) and would then renew for another fiscal year (July 1, 2025–June 30, 2026).

Lee County, Georgia, pursuant to O.C.G.A. 48-13-50, is authorized to collect a 7% hotel/motel occupancy tax. In past years, this has been a relatively small amount due to the fact there is only one motel in the County. Recently, with the growing number of short-term rentals throughout the County, this amount has increased. To be compliant with O.C.G.A. 48-13-51 (a) (4.4), the County is required to expend 28.58% of the hotel/motel tax collected annually for the purpose of “either marketing or operating a community auditorium or theater facility or a community convention or trade center of which the theater or auditorium is a part”.

Since a large portion of Chehaw Park is in Lee County, and they operate the Creekside Center, they qualify for up to 28.58% of the County’s hotel/motel funds. These funds must be spent by June 30 of each fiscal year. This contribution is estimated to be approximately \$8,500.00 each fiscal year.

This item was tabled until the next meeting.



SUBJECT: Back Up 911 Center Radios

DATE: April 22, 2025

The purpose of establishing a **Backup 911 Center** is so that in the event the E-911 Center is compromised, staff can be moved to this alternative location to maintain service to our citizens. To completely wire the backup facility would cost approximately \$360,000.00. Fiber would not only have to be run to the building, but a secure server room would also be required. Along with all the required hardware and software, three (3) consoles that are identical to those in the E-911 Center would need to be installed. The server room along with the consoles would take up so much space in the new building.

In place of wiring the building, **there are two alternative options**. The **first option** includes purchasing three (3) mobile units called consolettes that can be securely stored and set up in minutes when needed. These consolettes are quoted at **\$31,709.46**. The **second option** includes purchasing three (3) regular mobile units that can be plugged in with a mag lock antenna and again be operational within minutes if necessary. The total cost of these units is **\$16,645.89**. Quotes for both options are attached for your review.

Staff recommends buying the three (3) consolettes mobile units from Motorola at a total price of \$31,709.46. The consolettes offer more functionality and can be repurposed as full consoles if needed. This equipment will be paid for with SPLOSTVII funds.




Staff requests to enact the following policy for speed humps:

1. Public Works receives the initial request from citizens.
2. Public Works will then inspect the area to determine where the speed hump would potentially be placed.

SUBJECT: Lakeview Mobile Home Park

MEETING DATE: Tuesday, April 22, 2025

Thomas Fabris, owner of the Lakeview Mobile Home Park located at 284 Linden Road, has reached out to Leesburg City officials requesting to be connected to the city water system. This mobile home park is within the County, but the Utilities Authority does not service this area.

Article 9, Section 2, Paragraph 3, Subparagraph (b) of the Georgia Constitution states that if a local government entity proposes to provide certain public services, including water services, to water customers residing in the unincorporated area of the County (i.e, residing outside of the City), the City's provision of such services to a customer residing in the County is only legally authorized if the requesting City and the corresponding County enter into a contract authorizing the City to provide such services within the unincorporated portion of the County. The contract needs to be in writing and be approved by the governing body of the City and by the governing body of the County before such services can be provided by the City. The maximum term of such a contract would be 50 years, but that term can, of course, be less than 50 years, depending upon what the City and the County agree upon when negotiating the intergovernmental contract.

Staff has reviewed this request and are recommending an intergovernmental contract with the City of Leesburg that will allow them to service this area. The Utilities Authority had no objection to this water service proposal per their April 17, 2025 meeting. Upon approval from the Board of Commissioners, EPD requires one of the following items to occur before approval from them:

1. The mobile home park will need to be annexed into the City of Leesburg so that the project is in accordance with the current approved Service Delivery Strategy.
2. The Service Delivery Strategy will need to be updated to show that Leesburg can serve water to an area outside the City, including the entire area of the mobile home park.

MOTION/RECOMMENDATION

Motion to approve an Intergovernmental Agreement with the Chehaw Park Authority relating to the expenditure of hotel-motel tax funds received by the County under Title 48 of the Georgia Tax Code.

BACKGROUND

Lee County, Georgia, pursuant to O.C.G.A. 48-13-50, is authorized to collect a 7% hotel motel occupancy tax. In past years, this has been a relatively small amount due to the fact there is only one motel in the County. Recently, with the growing number of short-term rentals throughout the County, this amount has increased.

To be compliant with O.C.G.A 48-13-51 (a) (4.4), the County is required to expend 28.58% of the hotel/motel tax collected annually for the purpose of “either marketing or operating a community auditorium or theater facility or a community convention or trade center of which the theater or auditorium is a part”.

The Board recently approved an agreement with the Chamber to authorize them to provide marketing for Lee County with this 28.58% funding, approximately \$8,500.00.

Since the majority of Chehaw Park is in Lee County, and they operate the Creekside Center, they qualify for up to 28.58% of the County’s hotel motel funds. These funds must be spent by June 30 of each fiscal year. We estimate this contribution to be approximately \$8,500.00 each fiscal year.

**AGREEMENT BETWEEN THE BOARD OF COMMISSIONERS OF
LEE COUNTY, GEORGIA AND THE CHEHAW PARK AUTHORITY
REGARDING THE PROVISION OF TOURISM SERVICES**

This Agreement, entered into effective the ____ day of _____, 2025, by and between the **Board of Commissioners of Lee County, Georgia**, a body corporate and politic whose mailing address is 102 Starksville Avenue North, Leesburg, Georgia 31763 (hereinafter referred to “County”) and the **Chehaw Park Authority**, of 105 Chehaw Park Road, Albany, Georgia 31701 (hereinafter referred to as the “Authority”).

WITNESSETH:

WHEREAS, the County is a body corporate and politic established in accord with the provisions of Article IX, Section 1, Paragraph 1 of the Constitution of the State of Georgia; and

WHEREAS, the Authority is a public body corporate and politic which is an instrumentality in a public corporation of the State of Georgia originally established in accord with Georgia Laws 1981, Page 31-31, as amended; and

WHEREAS, the County is authorized, pursuant to general law, to provide funds for the promotion of economic development and tourism within the unincorporated area of Lee County; and

WHEREAS, tourism is the second largest industry in the State of Georgia and provides a substantial amount of economic development in the Lee County area; and

WHEREAS, the County has previously levied a hotel/motel tax as authorized under O.C.G.A. §48-13-51 to provide for the promotion of tourism, conventions, trade shows, and other expenditures of such funds as authorized under such statute within the unincorporated area of Lee County; and

WHEREAS, the Authority deems it appropriate to assist in the provision of tourism services for Lee County.

NOW THEREFORE, in consideration of the premises and in consideration of the mutual obligations, agreements, and undertakings hereinafter set out, the County and the Authority do hereby agree as follows:

1. The Authority is authorized to make, execute, and enter into contracts necessary and convenient in connection with its operation of the Chehaw Park located in Lee County and Dougherty County in southwest Georgia and, in accord with this Contract, the Authority shall provide services to Lee County in connection with the promotion of tourism, conventions, and trade shows within Lee County, and shall undertake such programs and activities as it may deem appropriate in order to improve, enhance, and encourage tourism within Lee County so as to promote and enhance economic development of Lee County and for the benefit of the citizens of Lee County, particularly with respect to visitation to Chehaw Park.

2. In consideration for the services to be provided by the Authority hereunder, the County shall, and does hereby, agree to pay to the Authority an amount up to 28.58% of the hotel/motel tax collected annually by Lee County in accord with the provisions of O.C.G.A. §48-13-51(a)(4.4). Such payments shall be made to the Authority monthly, quarterly, or annually as the County may deem appropriate.

3. The parties agree that this Agreement shall commence as of January 1, 2025 and shall expire by its terms on June 30, 2025 (the “original term”). The Agreement shall then automatically renew as of July 1, 2025, and shall expire by its terms on June 30, 2026. Either party shall have the right to terminate this Agreement, with or without cause, during the term hereof by giving thirty (30) calendar days’ written notice to the other party of such termination, and such termination shall be effective as of the 30th calendar day after the date of such notice of termination submitted by the terminating party.

4. The Chairman of the Authority, or his or her designee, shall make a written report at least annually in June of each year to the County regarding the activities of the Authority undertaken in accord with the terms of this Agreement. Such report may be required more frequently in the sole discretion of the County.

5. A detailed accounting of the amount and purpose of the expenditures made by the Authority under the terms of this Agreement shall be the subject of the Authority’s annual audit.

6. This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof, and no modification of this Agreement shall be binding unless the same is reduced to writing and signed by all the parties to this Agreement. No representation, promise, or inducement not included in this Agreement shall be binding upon any party hereto.

7. This Agreement shall be construed in accord with the laws of the State of Georgia.

8. All notices required or permitted to be given with respect to this Agreement shall be in writing. Each notice to the County shall be sent by registered or certified mail, postage prepaid, and return receipt requested, to:

Every notice shall be deemed to have been given at the time it shall have been deposited in the United States Mail, postage prepaid, in the manner prescribed herein. Nothing contained herein shall be construed to preclude personal service of any notice in the manner prescribed for personal service of a summons or other legal process.

9. This Agreement is binding upon the parties hereto and their respective successors and assigns.
